The texts may have the same or different authors, and you may compare or contrast the texts if you wish.

After you have chosen a question, complete the box at the top of page 4. You may use the space on page 4 to map or plan your ideas.

VISUAL OR ORAL TEXTS

QUESTIONS (Choose ONE)

A list of visual and oral language features is provided on page 3.

- 1. Analyse how symbolism was used to highlight the purpose of the visual or oral text(s).
- 2. Analyse how a sense of triumph or achievement was developed in the visual or oral text(s).
- 3. Analyse how visual or sound effects were used to emphasise a theme in the visual or oral text(s).
- 4. Analyse how the setting of time and/or place presented the values of a culture in the visual or oral text(s).
- 5. Analyse how the nature of a character or individual was revealed by their response to events in the visual or oral text(s).
- 6. Analyse how the interaction of characters or individuals created a sense of hope in the visual or oral text(s).
- 7. Analyse how tension was developed to show opposing viewpoints in the visual or oral text(s).
- 8. Analyse how a main character's attitudes and view of the world were presented in the visual or oral text(s).
